**Bonus** for both Certified Irish Angus & Farm Quality Assurance will be paid on steers and heifers under 30 months only.

# **CERTIFIED IRISH ANGUS BONUS**

- To qualify for these payments animals must fall within a weight specifications of 240kg – 380kg steers and heifers.
- Animals grading within the yellow & blue shaded areas will receive 10c/kg.
  - This will increase to 15c/kg in off Season production periods.
- Applicable dates will be communicated to members.
- A number of additional specialised bonuses are available under separate application.

# **FARM QUALITY ASSURANCE BONUS**

- To qualify for these payments animals must have been resident on a quality assured farm(s) for a minim of 70 days in total, with the final 60 days on the farm presenting them for slaughter
- Animals grading within the yellow shaded area will receive a bonus of 20c/kg
- Animals grading within the green & blue shaded areas will receive a bonus of 12c/kg

## TERMS AND CONDITIONS

- 1) All animals must be sired by a pedigree Angus bull
- 2) Identity cards must declare the breed of animal as Angus or Angus cross
- All animals must be polled
- 4) All animals must be booked in for slaughter with Certified Irish Angus producer group or a Procurement Manager in a participating meat plant who will duly notify Certified Irish Angus
- 5) The vendor's farm must be a member of the Bord Bia Sustainable Beef and Lamb Assurance Scheme prior to the slaughter of any animals
- 6) In the case of livestock inspections within participating meat plants, the Certified Irish Angus inspector will be the final judge by visual inspection as to whether an animal is suitable for the Certified Irish Angus program.
- 7) Agreement will be reached on an ongoing basis between participating meat plants and Certified Irish Angus on the specifications required for animals to be Certified and receive a bonus payment. These specifications may change and as a result effect bonus payments. Appropriate notice will be given to all relevant members in such cases.
- 8) Certified Irish Angus Bonus payments along with Farm Quality Assurance Bonus payments will be included in factory payment.
- A deduction of £6 including vat, per animal Certified will be made by the participating meat factory in favour of Certified Irish Angus Producer Group
